Turning Point believes that there is a high incidence of animal abuse in domestic violence situations and is committed to ensuring that no survivor should have to leave a pet behind as a condition of seeking a safe environment. We are exploring both off-site and on-site care for the family pets.

* The values for these naming opportunities are based solely on utility, placement, or perceived appeal and do not necessarily reflect the gift’s designated purpose or the actual cost. Donors are encouraged to consider undesignated gifts and/or the least restrictive designation. Plans for the Delaware Shelter are not final. If alterations are required that affect a commemorative gift, an appropriate substitute will be arranged in consultation with the donor(s). These naming opportunities are for the projected life of the buildings or for a minimum of ten years. When the time comes to refresh or rebuild the buildings, current donors will be given the first opportunity to sustain their support at the level that is appropriate at that time. In all instances, donors will receive permanent recognition for their generosity.
